INSTRUCTIONS FOR HOME SOLICITATION SALE PERMIT APPLICANTS

1. All applicants must appear in person to the Records Management center, Tax Deed Division, 235 West New York Avenue, DeLand, Florida.
2. The total fee of this application is \$100.00. \$85.00 payable (non-refundable) to Clerk of the Circuit Court and \$15.00 payable to the Florida Department of Law Enforcement (FDLE)
3. The applicant shall receive a Home Solicitation packet that includes the application and fingerprint card.
4. Complete the application form but do not sign. The applicant must sign the application in the presence of a deputy clerk who will administer an oath. To eliminate any delay, be sure that the entire application is complete except for the signature.
5. Complete a fingerprint card by taking it to the DeLand Police Department, 219 West Howry Avenue, DeLand, Florida, between the hours of 9:00 AM to 11:00 AM and 1:00 PM to 3:00 PM Monday through Friday except holidays, where you will be fingerprinted. The charge for fingerprinting is \$3.00 residents , \$5.00 non-resident. The applicant will return the fingerprint card to this office upon completion.
6. When the application and fingerprint card are returned a records search and fingerprint analysis will be processed.
7. The records check conducted by FDLE may take up to 60 days. We cannot issue a permit until this is received.
8. When the Clerk's office receives the results of the name search and fingerprint analysis, the applicant will be notified immediately by telephone or by U.S. mail.
9. After notification the applicant must return to this office in person to sign and receive their permit. At this time the applicant must present two (2) 2"x2" photos taken at a reputable studio or department store to the Clerk. One photo will be attached to the permit. The other photo will be attached to your application and retained on file with this office.
